#### **PREAMBLE**

THE 2021 WORLD ANTI DOPING CODE has been adopted on the 1<sup>ST</sup> January 2021 by WADA, worldwide and by the ISU, refer ISU Communication No.2344 and ISU Communication No. 2366 and any further and subsequent communications.

The CODE has also been adopted by SPORTS INTEGRITY AUSTRALIA and enacted as the AUSTRALIAN NATIONAL ANTI-DOPING POLICY.

#### **INTERPRETATION**

AUSTRALIAN NATIONAL ANTI-DOPING POLICY INTERPRETATION.

The AUSTRALIAN NATIONAL ANTI-DOPING POLICY requires that NSO's adopt the new policy unchanged, accordingly there is no point in continuing a separate ISA Policy.

Any reference in any ISA document referring to an ISA Anti-Doping Policy defers to the AUSTRALIAN NATIONAL ANTI-DOPING POLICY as adopted from the 1<sup>st</sup> January 2021.

This Anti-Doping Policy takes effect on 1 January 2021. In this Anti-Doping Policy, references to the Sporting Administration Body nationally are to be read as references to Ice Skating Australia Inc (ISA) that has approved this policy as the anti-doping policy for the sport of Figure Skating in Australia in accordance with ISA rules. Sporting Administration Body references in the policy to the International Federation are references to International Skating Union (ISU) that is ISA's International Federation.

The changes to the Australian Sports Integrity Anti-Doping Policy requires that National Sporting Organisations adopt the AUSTRALIAN NATIONAL ANTI-DOPING POLICY.

ANY PREVIOUSLY PUBLISHED THE ICE SKATING AUSTRALIA ANTI DOPING POLICIES are hereby superseded by the AUSTRALIAN NATIONAL ANTI-DOPING POLICY and no separate ISA policy will endure.

# WARNING TO ATHLETES, ATHLETE SUPPORT PERSONNEL, OFFICIALS and ADMINISTRATIVE OFFICERS

- All parties must be aware of the revised policies particularly in regard to Retaliation.
- All parties must be aware of the revised policies particularly in regard to education which will be covered in a separate forum.
