1. Covid 19

The Covid 19 situation is constantly changing and the ability to predict what national and international events will occur this season, at this point in time, is impossible to determine. As such the selection of judges for ISU International and Championship events will likely be effected by Covid 19. ISA will take into account the current situation in determining selection.

2. Purpose of the Policy

This Policy establishes the guidelines for selection of ISA Judges to International and ISU Championship Events.

3. Application of Policy

This policy applies to all Ice Skating Australia Judges

4. Definitions

5.Policy Statement

a. Eligibility

To be eligible for selection to Judge for Australia all nominees must:

- Be a current member of a State Association and be in good standing with ISA;
- ii. Have the qualification International Judge or ISU Judge as published in the current ISU list
- iii. Have judged acted as referee or technical controller at one ISA National/State events in the ISU season of application or previous 24 months;
- iv. Have judged at least one International event within 36 months of application to be eligible to judge at an ISU Championship event;
- v. Have a current passport, with 6 months validity;
- vi. Reply by the due date when applications are requested.

b. Selection Guidelines

Factors taken into account in the selection of Judges for specific events include:

- i. Meeting the eligibility requirements set out above
- ii. Previous events judged
- iii. Experience level
- iv. Activity needed to remain at their current level
- v. Activity needed to progress to the next level
- vi. Availability

c. Procedure

To have Judges nominated/selected to International events there usually needs to be ISA skater(s) competing at the event(s). This can mean that sometimes requests for applications to Judge are short dated and or that appointments made may be subsequently lost if a skater withdraws from the event.

After considering the Selection Guidelines the OD Judges and Officials will submit to ISA BOM the recommendations for the upcoming season.

The ISA BOM will make Judges appointments in consultation with and based on these recommendations.

Throughout the season the OD Judges and Officials may need to make further requests for

Judges and or make substitutions at short notice and therefore the ISA BOM may delegate this responsibility to the OD Judges and Officials.

d. Expenses

International events - Travel to/from is at the Judges own expense. Accommodation and meals are usually covered by the events Local Organizing Committee.

ISU Championship events – Travel to/from, meals and accommodation are usually covered by the ISU. Please refer to event announcements for clarification.

At times some expense/subsidy funding may be available from ISA according to the Judges/Officials budget for the international season.

At each State Associations sole discretion, and in accordance with their own policies, they may financially assist their Judges travel, accommodation and meals expenses.
